Marcia DeWitt of Rehoboth Beach, George Lorio of Dover, Richard Poole of Wilmington and Rehoboth Beach and L.D. Shank, III of Odessa will serve their first term as Trustees on the Biggs Museum Board.

Professor Lorio is a practicing and exhibiting sculptor and has over thirty-five years of teaching experience at the university level.

Richard Poole is a familiar face in the arts and culture world in Delaware. Mr. Poole is a retired attorney, formerly Partner and Chair of Potter Anderson & Corroon LLP in Wilmington Delaware. Mr. Poole has been an advocate for the arts for many years having served as past trustee and past Vice-President of the Rehoboth Art League; Collections Committee member for the Delaware Art Museum; Governing Board member and Board of Overseers of the Delaware College of Art and Design. He and his wife, Elisa also own AerieArt Gallery in Wilmington and Rehoboth Beach. Richard Poole has been a private collector of fine art for over fifty years.

L.D. Shank, III, a successful real estate entrepreneur, was raised in Philadelphia, Washington D.C. and Pittsburgh. After serving his country with distinction as an officer of the United States Army, he returned to his seven generation roots in Delaware. Mr. Shank has served on many boards including the United Way; Kent County Heart Association, The Wellness Community of Delaware; and the John Dickinson Mansion and Plantation.
